

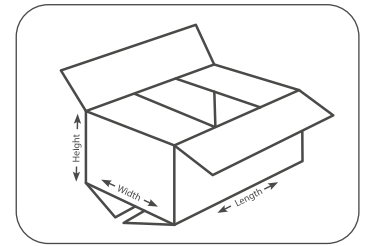

Rates terms and conditions

- ✦ All shipments are subject to our [general terms and conditions](#).
- ✦ Rates and surcharges exclude variable [fuel surcharges](#).
- ✦ Volume Key:
 - Economy: $L * W * H / 4000$.
 - Express: $L * W * H / 5000$.
- ✦ Standard maximum length: 270 cm, deviations are priced on request.
- ✦ Maximum circumference per package: 390 cm (2 x width) + (2 x height) + (1 x length).
- ✦ Deviations are priced on request.
- ✦ Rates exclude (mandatory) customs documentation preparation (e.g., ATR, T1).
- ✦ Rates exclude [Emergency surcharge](#).
- ✦ Transit Times: The indicated transit times are estimates and may vary.
- ✦ For import shipments, Seabourne Logistics relies on the dimensions and weights provided by the sender. Any discrepancies will be adjusted and charged accordingly.
- ✦ Additional Charges: Vat and Duty costs are passed on at cost.
- ✦ Maximum of 10 packages per shipment; otherwise, rates are on request.
- ✦ Shipments on pallets are forwarded via a different service; pallet rates are available on request.
- ✦ Booking Procedure for pallets:
 - Register shipments on Day A for pick-up on Day B. Contact our operations team at +31 (0)88 022 4800 for same-day pick-up.
- ✦ Both pick-up and delivery are without tail lift. If a tail lift is required, prices are available on request.
- ✦ For pallet shipments, a maximum waiting time of 15 minutes at loading or unloading addresses applies. Additional waiting time may incur charges.
- ✦ Rates are based on stackable pallets. If pallets are non-stackable, at least the euro light pallet rate applies.
- ✦ Invoice complaints must be submitted within 14 days of the invoice date.
- ✦ Seabourne Logistics is a forwarding agent and outsources transport assignments to third parties.
- ✦ Validity: Rates are valid until 31-12-2025. Seabourne Logistics reserves the right to adjust rates mid-term.
